1. Aims and objectives

The International Journal of Applied and Experimental Biology (IJAaEB) is an Open Access journal. This Open Access policy is designed to align with the indexing requirements of the Directory of Open Access Journals (DOAJ) and promote the sharing and advancement of knowledge.

2. Licensing

IJAaEB applies the Creative Commons Attribution License 4.0 (CC BY 4.0) to all published articles, as mandated by the DOAJ for inclusion in its directory. Under the CC BY license 4.0, readers and users of IJAaEB's content are granted the following rights:

- a. The freedom to share: Users can copy and redistribute the material in any medium or format.
- b. The freedom to adapt: Users can remix, transform, and build upon the material for any purpose, even commercially.

By publishing in IJAaEB, authors agree to let IJAaEB to publish their work under the terms of the CC BY 4.0 license. This license ensures that the article is available to the public while giving proper credit to the authors.

3. Author Retention of Copyright

Authors retain the copyright of their published articles in IJAaEB. This means that authors have the right to use, reproduce, distribute, and display their work. Authors can give permissions to others to do the same. IJAaEB respects and supports the intellectual property rights of authors. The journal also acknowledges their ownership of the published content.

4. Article Processing Charges (APCs)

To support the Open Access model and cover the publication costs, IJAaEB may require authors to pay Article Processing Charges (APCs) upon acceptance of their manuscripts starting from 1st January 2024. However, the APCs, when applicable, will be clearly communicated to authors during the submission and review process. In addition, IJAaEB strives to keep its APCs reasonable and offers fee waivers or discounts for authors from low-income countries or those facing financial difficulties. This ensures that everyone has equal opportunities to publish their work.

5. Archiving and Preservation

IJAaEB understands the importance of long-term archiving and preservation of scholarly content. All published articles are stored in digital repositories or databases to ensure they are accessible in the future. IJAaEB also encourages authors to self-archive their articles in institutional repositories or other appropriate platforms to enhance the visibility and reach of their research.
